The conference invoices each pastoral charge for the actual cost of its pastor's pension and health benefits, less a portion of the health benefit cost contributed by the pastor. It is expected that invoiced pension benefit costs will total approximately \$6,600,000 and invoiced health benefits costs will total approximately \$11,000,000, for aggregate benefit costs invoiced to the pastoral charges of \$17,600,000 for 2015.

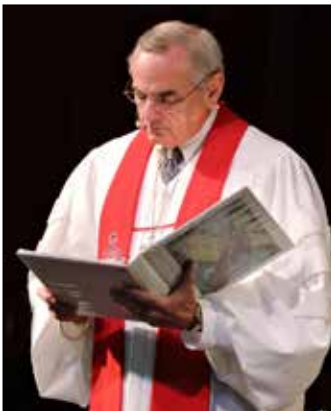
